Application Screening Guidelines

NO APPLICATION WILL BE PROCESSED UNTIL THE APPLICATION FEE HAS BEEN PAID.

Every occupant 18 years or older must submit an application and will pay a non-refundable screening fee of \$35.

All applicants must provide valid picture ID and Social Security card when submitting application. Upon approval, the holding fee/security deposit must be paid within 24 hours to hold your unit. All properties are rented on a first come, first served basis.

- 1. We will run a credit report. The Credit Reporting Agency will present a report on how bills have been paid, plus other information which has been turned in to them. We look for a positive report. Any judgement, liens, collection, or an excessive amount of late payments in the past three years are considered negative information. We do not accept Comprehensive Reusable Tenant Screening Reports. Students with no income may be accepted with a qualified co-signer residing in Washington State.
- 2. We require two (2) years of names, addresses and phone numbers of past landlords (not just current one, but also prior landlords.)
- 3. We require two (2) years of employment. Monthly verifiable income should be at least three (3) times the amount of monthly rent. A current pay stub may be required. Self-employed applicants will be required to provide proof of income with previous two years tax returns.
- 4. False (or missing) information on application will be grounds for denial. All information on your rental application must be verified absent extraordinary circumstances.
- 5. The full legal name of all proposed occupants, picture ID for each person aged 18 and over, and the relationship to other tenants must be disclosed. Failure to disclose this or moving another occupant in without prior written consent of landlord/manager is grounds for eviction.
- 6. If pets are negotiable on a particular property, they will be accepted on a pet-by-pet basis. Some breeds may require additional rental insurance coverage. A pet fee and/or additional damage deposit may be required for pets accepted by landlord/owner. Failure to disclose existing pet(s) or any additional pet(s) is grounds for eviction.
- 7. Smoking of any substance is not allowed inside the residence. Smoking outside must be at least 25 feet from the apartment buildings.
